

## AGREEMENT

I (we) acknowledge that the NCA test regulations have been made available to me (us) and that I am (we are) familiar with their contents. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents, or test secretary and the owner or lessor of the premises or grounds and the employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the test premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim or loss of this dog by disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person or any other causes.

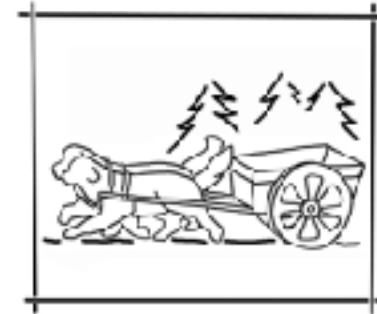

**Eligibility:** This test is open to all breed dogs of either sex that are at least 18 months of age on the date of the test. Bitches in season will be tested after all other entrants have been judged.

**Entry Fees and Policies:** There is a fee of \$45.00 per dog entered in either division. The test is limited to a total of 15 entries, regardless of division entered. There is a minimum requirement of at least 3 entries in order to hold the test. Please send all fees, payable to the Newfoundland Club of Seattle, to the Draft Test Secretary listed on the front of this premium list.

Entries close Friday September 29, 2015 at 7:00 p.m. Entries cannot be accepted, canceled, or changed after the closing date. If the number of entries exceeds the limit on the closing date, those dogs not yet having passed the division entered will have priority over requalifying dogs. Alternates will be assigned by drawing in case an entered dog is absent from the test. Confirmation of entry or alternate status will be emailed to entrants a minimum of ten days prior to the test date.

**Test Site:** Frontier Park is a public park. The test site consists of varied terrain including grassy areas, gravel and wooded paths, and paved areas. The freight haul may include hills. There is a picnic shelter at the test site and plenty of large evergreen trees shading most of the test area.

**Schedule of Events:** Check in will begin at the conclusion of the NCA draft test, also held on Saturday, followed by judges' instructions and maneuvering course and freight haul walk throughs. Testing will begin at immediately after with basic control.

**Hospitality:** A no-host dinner is planned for the night before the test. More details will be included in the confirmation letter. Coffee and a breakfast snack will be provided for entrants, judges, and stewards on the morning of the test. Each entrant is entitled to one lunch. Additional lunches are available for purchase for \$5.00 each.
